Active Ingredient: fipronil 0.1 g/kg in the form of a paste bait

Directions for use: Remove cartridge from vac bag. Cut tip from bait cartridge and place in dispensing unit. Squeeze small amounts of bait at regular intervals of 1.5-2.5 metres into cracks, crevices and shady places where Ants are seen. There may be variations in moisture content between cartridges. This will not alter the bait's attractiveness to ants nor its effectiveness. This product is a fresh bait made of natural ingredients without preservative. Therefore once the cartridge is opened use entire contents in one treatment and do not reseal. Dispose of any remaining bait in an approved way. Bait will take a few days to be effective. **DO NOT FLUSH DOWN SEWER OR ALLOW TO CONTAMINATE ANY WATER SUPPLY.**

Medium ant infestations, use one cartridge per 1100 square metres equivalent to 3kg/ha. **Heavy ant infestations**, use one cartridge per 550 square metres - equivalent to 6 kg/ha.

The extent and density of the ant population should be assessed before treatment so that the correct rate of bait is applied.

Repeat if ants re-invade the treated areas or after 12 months.

Broadcast application: This bait may be applied using a broadcast method with specialist application equipment. Refer to the manufacturer for specific details.
